 January 2018 yes agreed we will go ahead (Rules will be changing that everyone needs a qualifying umpire)
- ✓ Liz B volunteers for 11th November still needed (Liz has since confirmed that she is sorted for volunteers)

- ✓ Junior Netball League which Charlotte arranged, original costs were originally quoted wrong by Gateshead Stadium Liz and Charlotte have written to all clubs to let them know a further fee amount will now be due, next Junior matches commence January 2018
- ✓ Calendar Doodle/meeting for Christmas SJ sorted
- ✓ Cat to look into organising fastnet festival Liz checking schools tournament dates so no clash
- ✓ Ask Rachel C to add in England Netball officiating link into website and build out umpire detail
- ✓ County Schools Tournament 11th November venue Blue Flames we are predicting that we will have to subsidise this event by more than usual but the committee agreed to pay. This is partly because we have more schools entering so we may need to consider the affiliation add on amount or the venue for next year if the schools continue to support
- ✓ Katie reported that due to some issues with Northern League and to ease the collection of fees we will probably use My Net for the logging and payment of second affiliations (additional players) next season. (in progress)
- ✓ Cat Witty has been given permission to umpire Division 1 games with a mentor and Iain Richardson has also been given permission to do Division 1 with a mentor, in the County League, also Beccy Bailey will be umpiring Division 2 with a mentor .
