## County Squads

Reports were presented from the Under 16 and Adult squads. The Adult squad were unfortunately relegated to Division 4 and finished $36^{\text {th }}$ out of 68 teams at the Inter Counties Tournament. The Under 16 squad finished $26^{\text {th }}$ overall at the Alex Barlass. Many thanks are due to everyone who participated in the county season whether as player, coach, umpire or volunteer helper.

## Sponsorship

## Any other business

The question of teams wearing identical kit was raised. It was agreed that whilst teams were expected to play in a 'uniform' common sense needed to be exercised, and that it wasn't necessary for all players to be absolutely identical. In addition it was important that 'safety' was a key factor in any decision on appropriate clothing.

Where umpires do not turn up for league matches (unless they have a valid reason - validity will be decided by the committee) it was agreed that a five point penalty would be applied in the first instance and that financial penalties of at least $£ 20$ would be applied for second and subsequent occurrences. The financial penalty would be dependent on the costs incurred by the county and the teams whose game was affected.

It was proposed and agreed that when a team drops out of the league their place would be filled by a team moving up from the division below, rather than a team staying up despite finishing in a relegation position.

It was proposed that Division 1 matches in the summer should be further staggered - similar to the format used for Division 7 currently. This was in order to lessen the problems of providing B or above umpires for $1^{\text {st }}$ division games. This will be discussed further by the committee and an appropriate format arrived at.

The question of affiliation was raised. Tyne and Wear has a somewhat complicated affiliation structure which has not been amended since AENA moved to a single affiliation system. Because of this some anomalies and inequities have arisen over the year and these were debated by the meeting. It was agreed to construct a questionnaire which would collect clubs views on affiliation and feed this into committee discussions in order to address the issues raised.
